Kitchen Inspection

The Food Hygiene Rating Scheme (FHRS) helps you choose where to eat out or shop for food by telling you how seriously the business takes their food hygiene standards.

The scheme is run by local authorities in England, Northern Ireland and Wales and applies to restaurants, pubs, cafes, takeaways, hotels, supermarkets and other food shops...and schools.

Each business is given their hygiene rating when it is inspected by a food safety officer from the business's local authority. The food safety officer inspecting the business checks how well the business is meeting the law by looking at:

- how hygienically the food is handled – how it is prepared, cooked, re-heated, cooled and stored
- the condition of the structure of the buildings – the cleanliness, layout, lighting, ventilation and other facilities
- how the business manages and records what it does to make sure food is safe

At the end of the inspection, the business is given one of the six ratings from 0-5. The top rating of '5' means that the business was found to have 'very good' hygiene standards. Any business should be able to reach this top rating.

We are thrilled to share with you that Mrs Allerton received the full 5 stars when our school kitchen was inspected last week.

Mrs Allerton is an asset to the school and we are very blessed to have her. Not only does she prepare freshly cooked dinners each day but she also takes responsibility for running our breakfast club every morning. She thoroughly deserves this outcome and I would like to thank Mrs Allerton for her hard work and dedication, we appreciate everything that you do.

Free school meals

Are you eligible for free school meals? If you are in receipt of any of the following benefits, even for a short-term temporary period, you can

apply to receive free school meals. Not only does this benefit your family by receiving free school meals and breakfast club, but the school also receives Pupil Premium funding for the duration of your child's primary education to enhance the learning provision for your child. Your child only need be in receipt of free school meals for a short period for the Pupil Premium funding to trigger for their whole primary school education. With additional pressures on tight school budgets, any additional funding we can secure will help us maintain our high standards of educational provision.

Please complete and return the attached form the school office if you are in receipt of any of these benefits, or have a temporary change of circumstances which triggers these benefits:

- Income Support – (IS)
- Income-Based Jobseekers' Allowance - (IB JSA)
- Income-Related Employment and Support Allowance - (IR ESA)
- Child Tax Credit, provided you are not entitled to Working Tax Credit, and have an annual household income (as assessed by HM Revenue & Customs) that does not exceed £16,190
- Universal Credit – during the initial roll-out of the benefit
- A "Run-on" of Working Tax Credit - the payment someone may receive for a further four weeks after they stop qualifying for Working Tax Credit
